The General Directive College of Regnum Christi,

- according to what is stated in n. 65 and 78 § 3 of the *Statutes of the Regnum Christi Federation*;
- seeing the need to coordinate more effectively in the preparation of the next General Convention;
- having heard the opinion of the lay members attending the General Directive College;

## **ESTABLISHES**

The Preparation Commission for the General Convention of the Regnum Christi Federation. This commission shall be in effect until the beginning of the General Convention and shall be composed of the following members:

- Dcn. Matthew Bender
- Javier Bendek
- Fr. Rafael Ducci
- Viviana Lemon
- Fr. Aaron Smith
- Gina Chavez

As mandated, this commission will be entrusted with – among other things – the following tasks:

- 1. Propose the themes and methodology for reviewing those aspects or topics of the Statutes of the Regnum Christi Federation and the secondary documents (The General Regulations of the Regnum Christi Federation and The Rule of Life of the Lay Faithful Associated to the Regnum Christi Federation) that require particular study to the General Directive College.
- 2. Propose the topics to consider and a methodology for the evaluation of the implementation of the Regnum Christi Federation, particularly regarding the

general and territorial governments, to the General Directing College, elaborating the strategies and tools that are necessary.

- 3. For the local phase of preparation (September 2022-June 2023)
  - a. Support the territories in designing the local process for the apostolic discernment of reality, offering training and accompaniment.
  - b. Support the communication of the content and identity of the process and create mechanisms for collecting information.
- 4. For the territorial phase (September 2023-December 2023)
  - a. Define a mechanism for the collection, consolidation, and analysis of local contributions.
  - b. Create a proposal for *The Regulations for Participation in the Territorial Convention*, respecting what is indicated in the *Rule of Life of the Lay Faithful Associated to the Regnum Christi Federation* (n. 40) on the participation of the lay members, according to the global numbers that are collected in the RC Member Registry as of January 1, 2023. This draft is to be approved by the General Directive College after hearing the opinion of the General Plenary Council.
  - c. Create a proposal for *The Regulations for the Operation of the Territorial Convention*. This draft is to be approved by the General Directive College after hearing the opinion of the General Plenary Council.
- 5. For the General Convention (April-May 2024)
  - a. Define a mechanism for the collection, consolidation, and analysis of territorial contributions.
  - b. Create a proposal for *The Regulations for the General Convention* (including operations and participation), respecting what is indicated by number 69 of the Statutes.

Given that there is no Regulation approved by the previous General Convention (since when the 2018 Convention occurred the Federation had not yet been constituted), this proposal will be approved by the General Directive College after hearing the opinion of the General Plenary Council, and will be ratified or modified at the beginning of the 2024 General Convention by its participants.

6. Be available to the territories to address concerns, either personally or by email.
